\$ 20.00 ROAD REPAIR (TO BE HELD UNTIL WE HAVE ENOUGH)  
\$ 37.00 TOTAL

IT WAS VOTED THAT WE WILL BE CALLED THE CLEMONDS POND CORPORATION.

THE ROAD WAS DISCUSSED IN SOME LENGTH, ABOUT THE DEBRIS ON THE SIDE OF THE ROAD, THE WIDTH OF THE ROAD, IF WE HAVE A 10FT RIGHT OF WAY INTO THE CAMPS. THE OFFICERS ELECT WILL LOOK INTO THAT. WE DECIDED THAT NOTHING WOULD BE DONE ABOUT THE ROAD UNTIL ALL LEGAL RIGHTS ARE KNOWN. THEN IT SHOULD BE FIXED AS SOON AS POSSIBLE, IF THE MONEY IS AVAILABLE.
